Dr. Tenpenny explains what is in each flu shot, “By the time the flu shot is ready for packaging, the solution contains the following: various egg proteins, viral contaminants from the eggs, Triton-X100 (detergent), formaldehyde (known carcinogen), resin, gelatin, tri-butylphosphate, polysorbate 80 (chemicals), and in some instances gentamicin (antibiotic). To preserve this chemical brew, in doses of up to 25 micrograms thimerosal (a mercury derivative) is still added to some of the shots. After detailing this vivid description of the manufacture of the influenza vaccine, the thought of injecting this into your body-or the body of your baby-should be repugnant.”

As recent as a few weeks ago, the government conceded the first vaccine-autism case.
