Following the concepts of multi-level marketing, \$40 payouts are also rewarded for the member's referrals that bring in additional people. No middleman or waiting period is involved in this process making the system simple and easy to use.

The “Instant List” is one of the program's unique offerings that separate itself from the other opportunities. A list size composing of 5,000 subscribers is given for free as soon as the visitor signs up and pays the \$57 one-time registration fee. All 5,000 of these subscribers are real people that are looking for real opportunities. An additional 1,000 members are given for every new person personally referred in addition to the \$300 commissions.

Other member benefits include a fully functional website similar to the one shown at <http://www.simpleandlucrative.net> coupled with real-time tracking stats to help manage subscribers, opt-ins, and personal referrals. Custom setup options can also be requested as well as free customer support for any problems to be dealt with. In addition to the video library of more than 50 b videos, 10 autoresponder letter

templates are included for follow-up e-mail purposes.

“Simple and Lucrative” is a working system backed with payment proofs paid out to real members and a structured system that is legal because of the products and training materials that are included with the \$57 purchase. More members are expected to join in soon as they are convinced of the payouts made and benefits offered.
