The IRS can serve the Final Notice to Levy / Notice of Wage Garnishment in person, leave it at the

taxpayer's home or usual place of business, or send the Notice of IRS Wage Garnishment to the last known address by certified or registered mail. It is important to note that the IRS is only required to send the Final IRS Levy Notice ( Final IRS Wage Garnishment Notice) to the last address known to it. The taxpayer does not need to actually receive the Notice for IRS Wage Garnishment for it to be effective. Many taxpayers never actually receive the IRS Garnishment Final Notice. Those taxpayers may not realize they are in danger of receiving an IRS Levy / IRS Wage Garnishment until their wages are actually garnished.

The IRS can demand of an employer that a portion of the IRS Wage Garnishment be sent directly to the IRS. Section 6334 does allow for an exempt amount that must remain outside of the IRS Wage Levy / IRS Wage Garnishment. That amount is relatively small, sometimes leaving the taxpayer with hardly enough to satisfy your regular living expenses. An IRS Wage Levy / IRS Wage Garnishment upon your paycheck is considered to be a continuous IRS Wage Garnishment / IRS Wage Levy, i.e. it needs to be applied only once and will be applicable to future wages until either released by the IRS under §6343 or the debt is fully paid. So as future wages are earned, no additional IRS wage garnishment / IRS wage levy action is necessary by the IRS to take a large portion from them.

## SOCIAL SECURITY GARNISHMENT

Section 6334 (c) of the Internal Revenue Code (26 U.S.C. 6334 (c)) allows Social Security benefits and SSDI to be levied to collect unpaid Federal taxes;

If you are a Senior Citizen (also applies to someone with a Social Security Disability Garnishment by IRS) relying on Social Security or SSDI for your income and you have a Social Security Garnishment by IRS that is taking a portion of your check DWK TAX WILL STOP the IRS Wage Garnishment.

The IRS is not limited by IRC 6331(h) to taking 15% of a taxpayer's Social Security benefits. The IRS can issue a manual levy that can continuously take all of the social security benefits under Internal Revenue Code section 6331(a), which permits levy on all wages, salary or other income (which would include Social Security). The 15% automatic IRS Levy provision is a supplement to the manual IRS Levy power. The IRS can chose the manual approach if it deems fit and attempt to collect more than the automated 15%.
