

## **New Mobile Forensic Solutions Provider Opens for Business**

*Katana Forensics will provide “niche” software, training for popular mobile devices*

It takes a “one device, one tool” niche approach to mobile forensics. “Rather than support 90% of mobile devices on the market, Katana's software supports just one at a time,” said Sean Morrissey, managing director. “This focus means it can recover more data than conventional mobile forensic tools, and allow examiners to analyze that data as well.”

Katana Forensics training is vendor-neutral. Its software is taught, but is not the focus of training. “Our training instead provides investigators with a full toolbox of software,” said Michael Harrington, the company's director of training. “We teach them how to apply a variety of tools to proper forensic methodology.”

Katana Forensics also designs its tools to be easy to validate, meaning examiners will be able to prove it does what it says it does in court.

Finally, Katana Forensics works in cooperation with mobile device vendors such as Apple. “We work with them so that we can develop better forensic tools without jeopardizing their competitive advantage,” said Morrissey.

New iPhone forensic software Lantern will launch at the DoD CyberCrime conference in St. Louis, Missouri this week. Priced at just \$399, the software is meant for investigators who cannot afford to spend thousands of dollars for a forensic tool. A free trial version with limited features is also available.
