Several energy retrofit programs will be available in the coming months within San Diego County. Rebate programs known as Homestar, SDGE's Whole house Energy Rebate and PACE will offer significant rebates or financing to reduce costs for energy efficient improvements. These improvements can be insulation, dual pane windows, weatherization and efficient heating/cooling systems that can qualify for \$1,500 - \$8,000 in rebates. Some rebates require energy audits to identify areas with the best return of energy upgrades. *"We have over 660,000 house built prior to 1980. Homes before 1980 may not have insulation in the exterior walls."* These homes will benefit the most from these programs. Home energy audits clearly demonstrate the need for energy efficiency. The good news is that many of these inefficiencies are very affordable.

Launch of these programs could start as early as September, 2010. Now is time for resources like certified & training home energy auditors and licensed contractors in HVAC, Insulation, window installers etc.

Home energy auditors must carry certifications from Calf Energy Commission (HERS), & Builder Performance Institute (BPI). Inspection Perfection is a certified HERS Rater.
